#### PROGRAM TERMS & CONDITIONS

The Agribusiness Center for Research and Entrepreneurship (ACRE), an initiative of the South Carolina Department of Agriculture (SCDA), connects entrepreneurs with new opportunities in agriculture, research and agribusiness to strengthen the state's economy, particularly in rural counties.

The ACRE Entrepreneurship Center ("Center") seeks the most innovative and forward thinkers in South Carolina agribusiness for participation in an Entrepreneurship Program (the "Program"). The Center is looking for companies and products it can help support in the marketplace through a collaborative effort. This program does not support research. Applicants may not have previously been awarded funds through the Advanced Program.

**Applicants selected to participate in the EC Program could receive a grant of up to \$25,000 to develop their product or business, as well as access to a network of business mentors and grant writing consultants.** This is a competitive program; not all applicants will be selected to pitch or receive funds. If you've received money in the Advanced Program before, you are not eligible to apply again.

Please read the Terms and Conditions carefully before completing and submitting your application. By submitting your application to the Entrepreneurship Center, you accept and agree to the following terms and conditions:

1. Applicant operates a business headquartered in South Carolina.
2. The product and/or company for which Applicant is applying must be agribusiness related, and specifically related to one or more of the following categories:
  - a. Specialty crops
    - i. Fruits and vegetables
    - ii. Tree nuts
    - iii. Dried fruits
    - iv. Horticulture
    - v. Nursery crops
  - b. Meat products
  - c. Other foods (honey, cheese, milk, eggs, etc.)
  - d. Hydroponics or aquaponics
  - e. Container, urban, or indoor farming
  - f. Aquaculture
  - g. Timber
  - h. Mechanical harvesting
  - i. Agribusiness technology
  - j. Agritourism/education (school tours, workshops, etc.)
  - k. Row crop value-added product/process
  - l. Food hubs (not restaurants)

3. Applicant must submit their business plan along with the Application. See [page 9](#) for required business plan elements.
4. Applicant's business must have sales history or must show a history of revenue from services being rendered. *If you have not reached this stage yet, we encourage you to apply to our Curriculum Program in the fall. Contact Kyle Player for more information.*
5. If Applicant is selected as a finalist:
  - a. Applicant must be able to pitch their product and/or company to our panel of judges.
    - i. Applicant must attend Pitch Day on May 13, 2026 at Phillips Market Center (PMC) at the South Carolina State Farmers Market in West Columbia, SC.
    - ii. Time slots will be set in coordination with the finalists.
    - iii. Must register (free) your business or non-profit as a vendor with the state at [procurement.sc.gov](http://procurement.sc.gov).
  - b. Finalists will be notified of the results by May 20, 2026.
6. If the Applicant is selected to participate in the EC Program:
  - a. Funds will be awarded upfront with a grant agreement, mandatory progress reports, and a site visit from ACRE staff.
    - i. Applicant must supply ACRE with periodic progress reports (timeline to be determined per awardee), including a line item budget for spending the awarded funds.
    - ii. Applicant will work with ACRE staff to set up a site visit to his or her operation.
7. Applications are due by **March 10, 2026** and finalists will be reviewed by our advisory panel. All Applicants will be notified if they have been selected as a finalist far in advance of the Pitch Day.
8. Priority will be given to applicants from rural counties and applicants with products or companies that would have a high impact in rural counties.
9. Applications will be reviewed based on merit as well as demonstrated financial need in the business plan. SCDA reserves the right to consider whether the applicant would be able to complete the proposed project without the requested grant funds.
10. Confidentiality Undertaking: SCDA recognizes that, as part of the application process, Applicants are required to provide SCDA and ACRE with Confidential Information related to Applicants' businesses and products. Confidential Information means all information in tangible or intangible form that is proprietary to the Applicant and has or could have value in the business or industry in which the Applicant is engaged. SCDA, ACRE, and their officers, directors, employees, agents, consultants, and representatives will hold in trust and maintain confidential, not disclose or make available to any third party whether orally, electronically, on disk, in writing, or otherwise, without prior approval of the Applicant, and not use for itself or for any third party (other than a use by a Party for the purposes stated above) any Confidential Information received from the Applicant or Applicant's agents.

# FOOD / FEED COMPLIANCE

To receive funding, you must be in compliance with all rules and regulations related to your product/business. **Please note, you do not have to be in compliance at the time of application, but if you are selected to pitch and are awarded funding, you must be compliant to receive these funds in May/June 2026.** Please carefully read below and answer every question. ## ■ WHOLESALE FOOD SAFETY

Ensures that foods are manufactured, stored, distributed, and marketed under safe and sanitary conditions through routine surveillance inspections.

## ■ MILK SAFETY

Regulates all Grade A Dairy facilities in the state that produce, haul, process, package, and distribute milk and milk products.

## ■ RETAIL FOOD SAFETY

Inspects retail food establishments statewide and issues permits to new facilities prior to opening. Retail food establishments include operations such as restaurants, grocery stores, food trucks, schools, and other institutions. Risk-based inspections are conducted at each establishment in the state annually or quarterly, based on an establishment's food processes and their compliance history.

## ■ PRODUCE SAFETY RULE

This regulation focuses on setting the first-ever federal regulatory standards for the production, harvest, and handing of fruits and vegetables. You can be exempt from this law if both of the below apply to your business:

- During the previous 3-year period, annual **food\*** sales are less than \$500,000 adjusted for inflation, and the amount of sales sold to qualified end-users exceeded the amount sold to all other buyers.

*\*The term “food” means (1) articles used for food or drink for man or other animals, (2) chewing gum, and (3) articles used for components of any such article.*

AND

- You sell more than 50% of your annual food sales to **qualified end-users** (consumer of the food and/or a restaurant or retail food establishment) located in South Carolina or within the same Indian Reservation or within 275 miles of your farm.

To protect the health of consumers by providing a comprehensive inspection service to assure that meat and poultry products are safe, wholesome, and accurately labeled.


